02.02	<b>The meetings of the Faculty Board</b> Buigel gives an explanation of the Leerling Volume Middelen (LVM) The LVM that the UG had received from the Ministry of OCW last year were distributed by the University Board among the faculties. However, it turned out that OCW had paid out too much and therefore came up with a correction. As a result, all faculties have to pay part of the LVM back to the University Board. In agreement, a budget-neutral solution was chosen: the reduction of the LVM is compensated by part of the work pressure funds that have not yet been spent.
